## **FAMILY BUSINESS**

Luke 2:49

Introduction: It was a common sight to see a business sign that read:
".....and Son or .....and Sons....such a business was one of my favorite television shows..."Sanford and Son.." Kathy remarked one day as Larry Caves and I cleaned out our garage, loading it onto his old truck," watching and listening to you two remind me of Sanford and Son".....A business with such a name usually included the entire family in its business matters...

I want us to take a look at **our family business** this morning..God's Family Business.

## I. THE FATHER STARTS THE BUSINESS

- 1. The Genesis passages reveal how, why and what business our Heavenly Father started. (1:1; 1:22 and Revelation 21:3-4)
  - created the world
  - populated the world with creatures
  - added a man and a woman
  - fellowshipped with them
- 2. Our Heavenly Father's business is His Family, having fellowship with those people whom He brings into His family.
- 3. Noah and his family were selected by our Father to start the business over.
- 4. From the new start, our Father then selected Abraham to be the source of a new family, a special nation, Israel, the Jews.

## II. THE FATHER TURNS THE BUSINESS OVER TO HIS SON

- 1. When the time was right, our Father sent His Son down here to continue the Family Business.
- 2. "How is it that ye sought me? Wist ye not that I must be about my Father's business?" Luke 2:49
  - He called people to Him

- He healed; He taught; He loved; He cried; He laughed; He revealed what the Father was like; He taught what the Father wanted; etc..
- 3. Jesus, God's Son, continued the Father's Business of bringing people into the Father's family until the Father called for Him to return Home.

# III. THE FATHER'S BUSINESS HAS NOW BEEN TURNED OVER TO HIS FAMILY

- 1. Jesus passed on the Family Business to the Family...Christians...the Church:
- "Go ye therefore, and teach all nations, baptizing them in the name of the Father, and of the Son, and of the Holy Ghost: Teaching them to observe all things whatsovever I have commanded you: and, lo, I am with you always, even unto the end of the world." (Mt. 28:19-20)
- -"But ye shall receive power, after that the Holy Ghost is come upon you: and ye shall be witnesses unto me both in Jerusalem, and in all Judea, and in Samaria, and unto the uttermost part of the earth." (Acts 1:8)
- 2. The Father has now entrusted His Family Business to us..the Church.
  - We are to continue where Jesus left off.
  - We are to bring people into our Father's family.
  - We are to teach people our Father's ways.
  - We are to follow our Father's Family rules.
  - We are to each do his/her duty within our Family.
  - We are to be obedient to our Heavenly Father.
  - We are to follow His Holy Spirit's leading.
  - His Son Jesus, His First Born is over us all and is our example of what our Heavenly Father wants us to be like.
- 3. God's Family is a special, peculiar family. To be a member of it is to be different from the rest of the world. We are to be a **holy** people.
